A - PURPOSE:

The Purpose of the Stake Emergency Preparation and Response Plan is to support and encourage participation in Emergency Preparedness planning in each unit.

Most Likely Emergencies:

Tornados and High Wind Flooding Winter and Ice Storms Heat Waves

B - Contents of the Unit plan should include:

Identification of goals and activities that encourage members to acquire a year’s supply of food, clothing, and, where possible fuel. The plan should also help members to prepare for unexpected emergencies.

A resource list of those in the unit/stake with special skills and/or equipment that could be used in an emergency.

C - Unit Level – should be reviewed and implemented asap after a disaster.

The priority of response should be:

1. Assist those who are injured or in danger.
2. Account for all families, assisting them to reunite as soon as possible.
3. Arrange for shelter and other selected services - keeping people as close to their property as possible in the homes of relatives, friends, and neighbors before sending them to public shelters or establishing a shelter in a Church meetinghouse.
4. Review damage to homes and determine ways neighbors can assist one another and make suggestions to this end.
